INTRODUCTION

FINANCIAL CHAIR'S MESSAGE


Greetings to the Trust Beneficiaries. This year marks eight years of Financial Trustees managing the assets by the terms of the Trust. As Financial Trustees, we are responsible for the assets, investments, and financial operations of the Trust. We engage professional investment managers, advisors, management, and staff to assist with governing the Trust. Our focus is to balance the Trust's financial ability to equally meet the needs of today's beneficiaries with those of our future generations.

2019 Results



Financially, the year-end Trust net balance increased by \$10,072,774 (8%), revenues rebounded to the highest level on record, and operational expenses increased below inflation levels. While investment results this year are exceptional, it is essential to remember that the financial markets are volatile. The effect of the global Covid-19 pandemic has impacted almost everything in our daily lives. Our Trust was not immune to the recent financial market volatility. The Financial Trustees have ensured we remain vigilant and focused on our disciplined investment philosophy and processes. We know that sticking with the Trust's prudent, long term investment plan and avoiding speculation or panic is the best way to protect capital and grow wealth for the betterment of our community.

It is important to note that the fluctuations in trust value are primarily due to 'paper' or unrealized gains or losses. We are pleased to report the 'actual' or realized income has remained at stable levels compared to previous years of Trust operations (as illustrated as 'Realized Revenue' in the graph below).

BACKGROUND

On June 29, 1998, after 91 years of struggle by Peguis First Nation, Canada confirmed it agreed with Peguis that the 1907 surrender of the St. Peter's Reserve was void and legally invalid due to Canada's failure to comply with requirements of the Indian Act of 1906. Canada and Peguis entered into negotiations to compensate Peguis for its loss of land and economic loss as a result of this illegal surrender.

On June 13, 2009, Peguis members voted in favour of the proposed settlement claim and the agreement was ratified by the parties on October 4, 2010.

The total settlement amount was \$126,094,903.00. Upon payment of settlement costs and legal fees, Canada deposited \$118,750,000.00 into the Peguis First Nation Surrender Claim Trust.

Looking forward to 2020 and beyond, we continue to strive for improved efficiency and capacity in Trust investment and operations. Continuous monitoring of key measurements and annual strategy planning are our primary methods of improvement.

The new reality brought on by the global pandemic has presented challenges in how we do business. We have indefinitely postponed physically hosting our Annual General Meeting (AGM). Our hope is the restrictions set by health authorities open to provide us with an opportunity for an AGM in the coming months.

Vacant trustee positions remain unresolved this year. The call for Trustee positions by an appointed nominating committee has yet to complete the process of restoring a full board of trustees. For the past five years, both Community Fund and Financial Trustee boards have operated with minimum members for a quorum.

I want to thank the administration of the Trust for their work supporting the Trustees responsibilities. Please take the time to read and digest the annual report. We strive to be open and transparent with Trust operations with the detail provided in this annual report and also by keeping our website updated with current information.

Most importantly, we thank you, the beneficiaries, for your continued support of the Peguis Surrender Claim Trust.

TRUST ACTIVITIES & EVENTS

Throughout the year, the Peguis Surrender Claim Trust engage in various activities to promote and support the Trust and the community.

Peguis Training & Employment Career Fair is held annually in March. It provides us the opportunity to present to the Junior and High School students from Peguis Central School about the career opportunities within the Trust industry and from Peguis based on the community planning discussions. Many students may not have considered a career in the trust industry or finance and management, these careers are much needed for Peguis.

The Annual General Meetings (AGM) were held in May, with sessions held in Peguis and Selkirk. The Peguis meeting was attended by approximately 200 people and we met with nearly

100 people in Selkirk. The AGM provides us with the opportunity to share the community fund application grants provided in 2018 and the update on the investments for the year. Proponents, those that received funding, are asked to make a presentation to the community to share their experience and benefits of funding from the Trust. The investment advisor, TE Wealth and an investment manager, are also available to present the update on the investments and the market effects. Our auditor is BDO and they present the audited financial statements and notes to the community. We are grateful that our partners can join us to present to the community and to be available to community members for discussion. An Annual Report is provided to the community, and the audited financial statements are also available for

distribution. We are thankful to the community for their attendance. There was a group of young men outside the community hall, who asked if we needed help and they helped setup and prepare for the meeting, we are thankful for their consideration and support.

Peguis Central School Heritage Day provided the Trust with the opportunity to share some of the history of the Anishinabek people, our migration to the west, the stories in our artwork, and the leadership provided by many community members. We wanted to acknowledge and share the rich history we have in Peguis and the trials and challenges our ancestors endured. We shared the history of the illegal surrender of St. Peters Indian Reserve and the home and lands we had lost to move to Peguis and set up new homes and a community.

Throughout the year, we engage in mentoring programs with the Training and Employment Program. They offer the Youth Mentorship Program and Adult Mentorship Program, whereby a Youth or Adult is placed in our office for a period of three months. During this time, we provide them with a job description and duties as an Administrative Assistant. In 2019, we had the opportunity to work with George Asham and Katy Sutherland.

The Interlake Reserves Tribal Council also held a mentorship program for young adults and we had the privilege of working with Anthony Thomas for a three month period.

The Trust held a Community Vote in August 2019 seeking approval for the Peguis First Nation Splash Pad Project. The project was seeking funding of up to \$500,000 for the construction of a \$650,000 Splash Pad. After receiving approval and recommendation from the Community Fund Trustees and Chief and Council, the community is required to approve any project funding over \$298,062.37. The community voted in favour of funding the Splash Pad project, with 350 registered voters: 243 voted yes, 42 voted no, and there were 2 spoiled ballots.

The Community Vote in August, also surveyed the registered voters at the meeting on whether Cannabis should be removed from the prohibited drug list, as it had been legalized in 2018. Currently, project applicants undergo a drug test as

a contingency to approval of their project funding. Anyone testing positive for a prohibited drug will have their application rescinded and not eligible for funding. The results of the survey were 125 voted in favour to remove cannabis from the prohibited drug list and 57 in favour of keeping cannabis on the prohibited drug list. As a result of the low turnout on the survey, the Community Fund Trustees have chosen to keep Cannabis on the prohibited drug list.

The Trust also administers a Summer Research position for a post-secondary student to assist and support the staff. In 2019, Tracey Stevenson joined our office and was provided with specific projects for her pursuit and undertaking over the summer. We also ask that the summer student seek out resources and supports for the youth, based on her peer group and their needs and to seek out opportunities available to the youth.

As the Peguis Summer Employment Program is one of our funded proponents, we also make our office available for placement for the summer students, during their two-week engagement.

The Trust participated in a Peguis Youth Forum held at the Community Hall, with presentations by the various organizations and programs within Peguis. We had our youth employees present on behalf of the Trust. They presented on what the Surrender Trust is and why we have one, the projects funded that support the youth, and potential project options and grants for the youth, as to what is possible. We hope to inspire the youth and share with them some of the projects funded by the Trust or by the projects undertaken by youth in other communities. Thank you to Tracey Stevenson and Mekhi Parisian for their contributions and presentation.

With the students back in school in the Fall, the office becomes quieter without the temporary summer staff. The summer students informed us that there are very few part-time employment opportunities for them after school. Based on these comments and support that students provide to our office over the summer, we instituted a part-time employment program for Grade 12 students. We focussed on the Grade 12 student who is pending graduation, to be able to provide them with some

resources: data, connections and financial, to assist them as they prepare for the next phase in their life. Working with the student in our office, also provides us with the opportunity to get to know the person, their schoolwork and activities and their recreational pursuits. We also get to share with them the work we are doing at the Trust for the community and resources we have available to assist proponents. We hope that the information and training that they receive from the Trust would build their confidence and provide them with support for their pursuits. Our offices were open to the community members and snacks were provided to the visitors, along with the opportunity to enter into draws for door prizes.

Midnite Madness & Community Draw was held to promote and support the community at the end of the year. Midnite Madness was attended by many community members and with a large variety of events and vendors available. To give back to the community and show our Christmas spirit, a draw was held for an Ethan Bear, Edmonton Oilers jersey and a Zach Whitecloud, Vegas Golden Knights jersey. We had over 600 people attend our booth. The proud winners of the jerseys were Kyle McCorrister for Zach Whitecloud and Greg Daniels' son for Ethan Bear's jersey.

CAPACITY BUILDING & PROFESSIONAL DEVELOPMENT

In our effort to ensure that the Trustees and staff keep abreast of the ever-changing Trust and Investment industry, they engage in professional development. The skills, resources and contacts made through these engagements offer many opportunities for the development, enhancement and growth of the Peguis Surrender Claim Trust.

As a leader in the Indigenous Trust industry, the Peguis Surrender Claim Trust encourages the sharing and distribution of knowledge with the community and beneficiaries. The community presentations allow us to build capacity with our members and to inspire the members to pursue their dreams and instil pride in their heritage and history of Peguis and the Trust.

NACCA National Indigenous Economic Prosperity Forum 2019 - The National Aboriginal Capital Corporation Association held their first annual conference in February 2019, in Ottawa, Ontario. Sharon Stevenson, Trust Manager attended this event to seek out resources, ideas and partnerships for the economic benefit potential of our clients. NACCA is the national organization for the Aboriginal financial institutions in Canada. Sessions included information on: Futurpreneur and providing financing, mentoring and support tools for small businesses and entrepreneurs, VanCity Financial and the partnership work they are doing with indigenous clients and supports for their economic initiatives; Business Development Bank of Canada (BDC) and their work with entrepreneurs and the supports from the Manitoba Regional office; Caroline Hilton from Indigenomics Institute provided the keynote address on the Indigenous economy and how much of an impact

we are having and can have on the national economy. The regional capital corporations were in attendance and were able to share some of their successes with the Awards banquet and to discuss access to capital for their clients.

NATOA National Conference was held in Vancouver, BC in May 2019 and is attended by trustees from indigenous trusts across Canada. This conference was attended by Elva McCorrister, Hal Sutherland and Sharon Stevenson-French. We were joined by Councillors Martin Favell and Kelvin Wilson at the conference. As first-time attendees, they were able to get a perspective on the role of the Trustee, the investment industry and to meet many trustees from other Indigenous communities and people in the Trust industry. At the Trustee Perspective session, we were able to share the challenges with being a Trustee in your community and trying to maintain the role of trustee versus a beneficiary. There were several presentations on wealth strategies, including ESG (Environmentally, Social and Governance investments), growth versus value and spending limits within the trust based on income generated and future demands. With about 250 delegates in attendance, we were able to visit with other indigenous Trustees, meet new and old trust industry professionals and see what was happening with other Trusts across Canada, that are valued in the billions of dollars.

Institute of Corporate Directors provides training for corporate board members on the roles and responsibilities of the board member. This training is provided over a series of four modules and is a nationally accredited designation. Errol Wilson, Financial Trustee had registered to undertake this training and designation. He has completed Module 1 – Guiding Strategic Direction & Risks: which provides a comprehensive overview of the fundamental board tasks and processes including director legal duties and responsibilities, overseeing strategic decisions, as well as managing group dynamics and decision-making in the boardroom. The three remaining modules will take place in 2020.

AFOA Canada National Conference, October 2019 was held in Saskatoon, Saskatchewan with the theme 'Managing Through Disruptions', which includes natural disasters, acts of god, cyber-attacks and community events. A timely theme, as many were affected by the debilitating snowstorm that followed the close of the conference. The AFOA National Conference receives approximately 1000 delegates, primarily from across Canada, however delegates have been attending from the US, Australia and New Zealand. With over 200 tradeshow booths and presenters, it is the premiere conference on indigenous finance. As a National Board Member of AFOA Canada, Sharon was asked to join a panel discussion on a Balance Approach Between Growing Wealth and Per Capita Payments, along with Chief Billy Morin, Enoch Cree Nation, Tim Laronde,

Peace Hills Trust and Miriam Jorgenson from the University of Arizona. As many Indigenous Trusts also attend this conference, this provides the opportunity to discuss opportunities and challenges with the Trusts.

Rodgers Trust & Investment Conference hosted their annual conference in Toronto, Ontario in October 2019. This conference was attended by Nikki Stevenson, on behalf of the Trust. The professional development opportunity includes the Investment Challenge Team. whereby delegates are placed in teams and must manage an imitation portfolio, including buying and selling stocks and bonds. This provides a good insight into the rise and fall of the markets, the effect of the environment on the value of the stocks and bonds and the opportunity to get to know other delegates on your team. The conference also provides educational information on Trust & investment basics, which is good for new Trustees or staff to be aware of the Trust as a legal document and a basic understanding of investing in stocks and bonds. There are also subsequent sessions for advanced Trust issues and Investments. A Trustee must also be aware of the fiduciary responsibility that they take on as a Trustee and the role and responsibility of a Trustee. The Per Capita Distribution with Trusts is always an issue, as to whether or not to have a distribution, and if so, how much. This session provided a great opportunity to discuss how the level of the distribution can positively affect the member and how a large per capita distribution can negatively affect the community and its future members. Another session she participated in was a discussion on community engagement, and how some communities have a hard time to get members to attend their community meetings and to get Trustees to represent their trusts. Luckily, in Peguis, we have some great supports from the community members who actively look forward to our Annual General Meeting and the updates from the Trust on our investments and the projects funded for the year. We also have tremendous support from our Investment Managers, Advisors and vendors, who proudly sponsor the door prizes and donations for our community meetings.

The Assembly of First Nations held a National Cannabis & Hemp Conference in November in Kelowna, BC. This conference was attended by Elva McCorrister and Debbie McElhinney. As Peguis is getting into the Cannabis industry, it is imperative that we be prepared and informed on any new or potential business ventures. This conference was able to provide a first-hand opportunity to discuss the feasibility of a cannabis production plant, the challenges and concerns regarding the Cannabis industry and operations and the opportunity to inquire with other First Nations on their experiences with cannabis regulations and development.

Trust Nominating Committee Members, as appointed by Chief and Council, are Dave McPherson, Victor Sutherland, Jordan Ulrich, Joanne Mason, Mike McDonald, Jeremy Hrappsted and Wade Sutherland.

In February 2019, the Trust Nominating Committee had filed their list of eligible applicants to stand for nomination of Trustee vacancy positions with Chief and Council.


Once the Chief and Council review and approve the eligible list of applicants, they would secure an electoral officer and call for an election of Trustees.

The Peguis Surrender Claim Trust Financial Trustees currently have three vacancies and the Community Fund hold two vacancies for Trustee positions.

TRUSTEE HONORARIUM

Elected Trustees are provided with an honorarium for meetings to a maximum of 18 meetings per year. Any meetings beyond the 18 approved meetings are not paid honorarium. The honorarium is recorded and paid out throughout the year. In some cases, the accrued honorarium will be paid out in the following year.

FINANCIAL OPERATIONS REPORT

Investment Income Received for the Period

The investment income and capital gains generated from Trust investments for the period was \$6,412,610.Of this amount, \$3,956,270 represents interest and dividend income and \$2,456,340 represents realized net capital gains.

Expenditures Incurred for the Period

Expenditures incurred for the period totalled \$1,508,593 and were comprised of corporate Trustee fees, investment management and consulting fees, Trustee honorarium and expenses and other professional fees as follows:

Expenditures Beneficial to the Beneficiary

The amount of \$2,909,554 was disbursed to the community for approved projects and programs. A project listing for 2019 is attached.

In addition, various project commitments from current and previous years, totaling \$1,137,289 have been approved and are expected to be funded in the following year.

Trust Property Approval Limits

Approval limits regarding applications for Trust funds increase each year by the rate of inflation. The Community Fund Trustees can approve amounts up to \$89,418.71, the Community Funds Trustees and Chief and Council can approve amounts up to \$298,062.37. Amounts greater than \$298,062.37 must be approved by the Community Fund Trustees, Chief and Council and the Members of Peguis First Nation.

Per Capita Distributions

An amount of \$10,500,000 was approved by the Initial Trustees in 2010 to fund per capita payments to eligible Peguis Band members. There were 9 applications processed in 2019 for a total amount of \$9,000. In accordance with the provisions of the Trust, any amount that remains after all the per-capita claims have been made is returned to Peguis to be used for community purposes.

US Tax Recovery

In August 2019, Max Reed Law Corp was able to secure reimbursement of US taxes paid on Trust investments based on the status of the First Nation Government. A refund encompassing three years, totaling \$171,655 was

returned to the Peguis First Nation. Going forward, US taxes are not paid on investments on US stocks.

Investment Activities of the Trust

The Trust funds are managed by TD Waterhouse Private Investment Counsel, Beutel Goodman Investment Council, Mawer Investment Management Ltd. and Ridgewood Capital Asset Management in accordance with the objectives of Peguis First Nation and as set out in the Trust Agreement and Investment Policy Statement.

Generally, the objectives are to provide safety of principle, stable and consistent income flow and capital appreciation. The investments consist of government and high-quality corporate bonds and equities. No more than 30% of the Trust funds can be invested in equities (stocks).

Line of Credit

To preserve the Trust Property, the Financial Trustees secured a \$15,000,000 line of credit with the TD Commercial Bank. The line of credit was utilized to fund the arena and housing projects, the larger capital grants. As of December 31, 2019, the balance of the line of credit was \$5,109,646. Interest is charged at the prime rate, which as of December 31, 2019, was 3.95%.

Value of the Trust

The value of the Trust investments as at December 31, 2019 was \$139,439,159.

The net value of the Trust as at December 31st (excluding the line of credit and accrued liabilities) was \$134,234,117.

THE YEAR IN REVIEW AS OF DECEMBER 31, 2019

We are pleased to report that the combined holdings of the Peguis First Nation Surrender Claim Trust appreciated 11.37% in absolute terms over the year, which outpaced the market benchmark return of 10.78%. Worth noting, the Trust continues to provide a very solid average annual return since inception of 6.73% or an appreciation of \$60,060,482, which has added value over the market benchmark return by a modest 1.08% as illustrated in Chart 1 below.

The Peguis First Nation Surrender Claim Trust is managed under a multi-manager structure as a risk management strategy thus diversifying the investment risk between two investment management firms being Beutel, Goodman & Company Ltd. (Value style manager) and Mawer Investment Management Ltd. (Growth-oriented strategy). Over time, the markets will tend to favour one style of management or another hence the benefits of such manager diversification.

Given the income requirements and significant weight in bonds within the Trust, Ridgewood Capital Asset Management was hired to provide a higher yield fixed income strategy to complement the TD Emerald Canadian Bond Index Fund.

Chart 1 – Overall Trust Returns against Market Benchmark




Chart 2 - Balanced Manager Returns against Market Benchmark





Chart 3 – Fixed Income Returns against Market Benchmark




Chart 4 - Top Ten Equity Holdings as at December 31, 2019



Chart 4 above documents the top ten holdings and highlights the percentage weight of each security as a percentage of the total portfolio. As noted, there are no securities within the portfolio that make up more than 0.7% of the portfolio which limits the risk of the Trust should any single security decline significantly in value.

What a difference a year makes! Thoughts of market resilience replaced fear and gloom. In December 2018, equity markets were in free fall over concerns that the U.S. Federal Reserve's (Fed) overly hawkish policy would drive the U.S. economy into a recession. But in one of the fastest stock-market recoveries on record, the S&P 500 Index finished 2019 with a total return of over 31%, in U.S. dollar terms, while the S&P/TSX Composite Index returned a healthy 23%. True, the results are not as formidable when measured over the 16 month period beginning in September 2018, before the market began its 20% slide, but the change in sentiment was impressive. Investors were encouraged that the U.S. and China took the first steps towards reaching a deal on trade, and the Fed's change in policy, which led to three rate cuts in 2019, improved the outlook for global and U.S. economic growth. An additional bonus for the U.K. and European economies was Boris Johnson's election victory and his plan to "get Brexit done", because it removes much of the uncertainty of the past three years.

The Peguis Surrender Claim Trust portfolio posted a return of 13.9% for 2019. The portfolio continues to perform well and remains structured to provide annual income to meet the needs of the community today and growth for future generations.

The Surrender Trust's investment portfolio at Mawer gained 15.88% in 2019 and outperformed the benchmark which was up 14.75%. This year closed with a strong rally in which equity markets capped off a remarkable comeback globally after a weak 2018. The improvement in investor psychology that began in early 2019 with central banks' recommitment to lower interest rates, further improved in Q4 as some of the uncertainty investors had been concerned about was removed: negotiations between the U.S. and China appear to be progressing, the Conservatives' decisive election victory in the U.K. gave Brexit better clarity, and, closer to home, the results of the Canadian election largely signaled continuity. The US stock market led the way as the S&P500 gained 25% in Canadian dollar terms with the TSX close behind at 23% for the year.

The portfolio's asset mix has been maintained near the target for equities rather than allowing the weight to move higher as there continues to be economic uncertainty looking forward and stock values have moved higher. The equity mix is tilted towards global equity and less in Canada as there is broader opportunity to diversify globally and we continue to be concerned about the energy sector and high debt carried by Canadian households. As always, we continue to fortify the portfolio by diversifying across wealth-creating companies, with excellent management teams, that trade at a discount to our estimate of their intrinsic value. We believe this builds a level of resilience into our portfolios in the face of many different scenarios during uncertain times.


